BOARD ACTION:

Approved Monthly Financial and Investment Statements: The Board approved the district's financial and investment statements for the months of June and July 2009.

Increase in Position F.T.E./Hours: The Board increased the F.T.E./Hours of the following staff members: **Mark Vanderpool**-Teacher Aide/Berlin & Edison from .56 F.T.E. (4/5 hrs. day/187 days) to .69 F.T.E. (5.5 hrs. days/187 days); **Bobette Nemire**-Teacher/Berlin Elementary from .70 F.T.E. (6 hrs. day/175 days) to .84 F.T.E. (7 hrs. day/180 days) and **Saunja Battle**-Teacher Aide/Berlin from 184 days to 187 days.
