## BOARD ACTION:



pproved Monthly Financial and Investment Statements: The Board approved the district's financial and investment statements for the month of August 2009. The Board also approved the annual appropriation resolution.

Increase in Position F.T.E./Hours: The Board increased the F.T.E./Hours of the following staff member: **Laura Dingle-Teacher/Milan** from 6.0 hrs. day/187 days to 7.0 hrs. day/187 days.

Accepted Gifts and Contributions: The Board accepted the following donations/contributions: **Troy & Linda Lombardi**-donation of \$650.00 to the Edison Football program; **ICI Paints**-donation of 500 gallons of field marking paint (Value \$4000.00) to the Edison Athletic Department; and **Target**-donation of \$75.02 to Edison High School from their *Take Charge of Education* fund.

Approved Overnight Field Trips: The Board approved the following field trips: **Edison High School Wrestling Team** to attend a wrestling tournament in North Canton from Friday, December 18-19, 2009 for the North Canton Hoover Holiday Tournament and **Edison High School Wrestling Team** to attend a wrestling tournament in Brecksville, Ohio from December 28-29, 2009 for the Brecksville Holiday Wrestling Tournament.

Approval of Service Contract with Wood County Educational Service Center: The Board approved the contract with the Wood County Educational Service Center to serve the educational needs of adjudicated and delinquent students from the district for the 2009-2010 school year.

Adoption of First Reading of the Adoption of Board Policies: The Board adopted the first reading of the following revised and updated policies: **Adoption of Written Policies & Procedures Regarding Determination of a Specific Learning Disability.**

Approval of Tuition Rate: The Board approved the Ohio Department of Education’s calculated tuition rate of \$4,310.36 for the 2009-2010 school year for the district. This amount is set by the State Department of Education even though Berlin-Milan Schools does not accept tuition students at this time.

Appointed Delegate and Alternate for the O.S.B.A. Capital Conference: The Board appointed Jodi Harris as delegate and Donald Gurney as alternate for the OSBA Capital Conference for the 2009-2010 school year.

Approval of Memorandum of Understanding (OAPSE): The Board approved the Memorandum of Understanding with the Berlin-Milan Classified Employees, Local No. 350, OAPSE/AFSCME/AFL-CIO beginning with the 2009-2010 school year in regard to transportation hours.

Approval of Agreement for Transportation: The Board approved the agreement with Senior Enrichment Services for transportation for a special needs student for the 2009-2010 school year.

Approval of Contract for Electric Provider: The Board approved an agreement with FirstEnergy Solutions Corp. through Ohio School Pool for electric services for the district.

**Other Actions:** The Board also...approved community requests to use school facilities...employed certified and classified substitutes for the 2009-2010 school year....employed recognized volunteers for the 2009-2010 school year. The Board also held an executive session before adjourning.
